



## ABSTRACT SUBMISSION GUIDELINES

EO 2026 | 24-26 SEPTEMBER 2026

The submission platform will be available from **January 5, 2026** until **May 6, 2026**. We kindly ask you to read these guidelines before submitting your abstract.

Notification of acceptance will be sent to authors early **July 2026** at the latest.

### GENERAL RULES

1. The abstract must have received an Ethical Committee approval before being submitted  
<https://eao2026.abstractserver.com/submission/>  
Abstracts sent via email won't be accepted, nor late submissions.
2. Due to the numerous submissions, we kindly remind you that all abstracts cannot be accepted, nor in the expected category:
  - **Oral Communications:** Presentation of your research for 12 minutes (8 minutes presentation and 4 minutes questions) in a dedicated session in the EO 2026 scientific programme.  
No online presentation.
  - **ePosters:** Presentation of your ePoster in a dedicated area in the Exhibition Hall. There is no dedicated time for ePosters presentation in the programme, as these are available at any time throughout the congress days.
3. By submitting an Oral Communication, you are automatically a candidate for the Award of the Best Oral Communication (1 award per topic). To ensure a smooth organization, you will be asked to share the **WhatsApp number** of the **presenting author**.
4. The **registration** is **mandatory** for the presenting author of an Oral Communication and for at least one co-author of an ePoster. By not respecting this rule, the Oral Communication will be cancelled, the ePoster will be withdrawn. Penalties will also occur to onsite no-shows.
5. After acceptance of your abstract, you will have the opportunity to be published in the **Clinical Oral Implants Research COIR** (Journal impact factor: 5.3. – the highest impact factors in the field of implant dentistry). As a reminder, the registration is **mandatory** to be published. The deadline to confirm the registration is **July 23, 2026**. Submitters will receive several emails before the deadline to confirm their registration status. By not replying to these emails, the abstract won't be published.

The abstract is published as it has been submitted, no modifications are permitted after the submission.



## SUBMISSION RULES

### 1. List of Topics

- Clinical research – surgery
- Clinical research – prosthetics
- Clinical research – peri-implant diseases
- Basic research
- Clinical innovations

Please note that the EAO Congress 2026 Abstract Committee reserves the right to reassign an abstract to a different category if deemed necessary. An abstract can only be submitted in one category.

2. The abstract may not exceed a total of 300 words. Abstracts must be submitted in English (Note: Please double check grammar and style of your English).
3. The abstract should be presented as follows. The 300 words can be shared into 4 text boxes, and they do not include the presentation title. All fields are mandatory.
  - **Title of the presentation** (25 words max.)
  - **Objective**
  - **Materials & Methods**
  - **Results**
  - **Conclusion**
4. Keywords must be selected, maximum 2.
5. Neither the title nor the content of the abstract shall provide indication about the origin of your research as the selection process will be blind to authors names and affiliations. All co-authors shall agree on the abstract submission. Any abstract not complying with the above-mentioned rules will be automatically rejected.
6. Authors will be permitted to submit their abstract as long as the abstract has not been published at the time of submission.
7. Authors confirm that they have been using generative AI **ONLY** to improve the English wording.
8. Authors confirm that ethical permits and approvals (if needed) are in place in accordance with regulations.



## GENERAL DATA PROTECTION REGULATION

By submitting an abstract for an oral communication or an ePoster, the author automatically gives the right to the EAO Congress 2026 organizers to use the content of the oral communication or the ePoster for educational purposes and on the EAO Online Library.

Please note that by submitting an abstract you authorize the EAO Congress 2026 organizers to keep your contact details and those of your co-authors as part of the congress activities only and for a maximum length of 3 years.
